How do universities prepare students for jobs of the future?

15:30-16:15

Session description:

Entire industries are emerging and vanishing at speed.
Political norms are shifting.
Environmental urgency is accelerating.
Up to 65% of today's students will work in jobs that don't yet exist.

Universities face a fundamental challenge: How do we prepare students not just for the future — but for the unknown?

This session invites UK and Uzbek institutions to explore their evolving role as future-makers, not just educators. It will highlight how inclusive, industry-informed, and transnational approaches can unlock the agility, resilience, and entrepreneurial mindset students now need.

- **Format:** Concise, provocative presentations (delivered by the session moderators) will frame the discussion, followed by an

inclusive, facilitated Q&A session that will involve the audience and encourage cross-cultural insight-sharing and collaborative dialogue.

This session will explore:

- The evolving internal and external context of higher education
- The entrepreneurial skillset: students need for agility, not just employability
- Utilising inclusive, industry-informed, transnational approaches to bridge the gap between institutional inertia and industry agility
- Enhancing existing higher educational practice for short-term wins
- Understanding the shifting values, expectations, and behaviours of students

	<p>Session Objectives</p> <p>A central characteristic of the Higher Education reforms is the granting of autonomy to higher education institutions. Critical elements of achieving this are effective governance and quality assurance. The session will discuss key priorities for higher education sector in Uzbekistan, present the outcomes and lessons learnt from initial pilots of University Governance and Quality Standards Draft Codes as a result of Uzbekistan-UK partnership work to strengthen capacity and pilot new co-created approaches. The session will explore how institutions can measure the effectiveness of their continuous improvement initiatives around quality assurance and university governance and how they create a culture that encourages feedback and innovation. It will also discuss the role of professional development in supporting continuous improvement. Presenters will explore the benefits of collaborative work in university governance and quality assurance to higher education institutions in Uzbekistan, discuss how this is enhancing ongoing reform and contributes to internationalisation and TNE development.</p>

	<p>Session Objectives</p> <p>The session will focus on the landscape of inclusive higher education in Uzbekistan and update on recent developments. Starting with an overview from the Inclusive University Working Group under the Ministry of Higher Education, Science and Innovations of the Republic of Uzbekistan (MHESI), it will go on to outline key practical steps to use Inclusive Higher Education stakeholder mapping and the Inclusive Higher Education Good Practice Guide by national and international initiatives intended to engage key stakeholders, raise awareness and support the enhancement of inclusive education in Higher Education in Uzbekistan. During the session lessons learnt from Uzbekistan-UK “English and Inclusion” higher education partnerships will be shared by project leads; the programme is part of AELLCA UK Government funded programme and delivered by the British Council. And finally, two new Uzbekistan-UK Disability Inclusion Partnership projects, led by the University of Westminster and the University of East London, will be launched.</p> <p>Session Outcomes</p> <p>The session is intended to support the further enhancement of inclusive Higher Education in Uzbekistan. It will present the outcomes of concrete projects to embed inclusive practices in university curriculum and launch two new projects aimed at ensuring that good practice in inclusive education is shared, implemented and widely embedded.</p>
